 - Deadline for Receipt of Proposals: Tuesday, June 30, 2020 by 4:30 pm HST.
 - You must use the provided application form which must be submitted with proposal and required attachments.
 - We will no longer be using the eCivis portal. Complete proposal must be emailed to contracting@gohta.net
 - i. Subject line of email and attached electronic file should be labeled to read: HTA

 - **ii.** The official time for receipt of the email shall be the date and time stamp automatically recorded on the email. Large files sometimes take longer to upload so please do not wait until the last minute to send.
- 3. 3.03 and 3.06. Confirmation of receipt method has changed.
 - All applicants will receive an email confirming receipt of submission, sent from contracting@gohta.net, no later than Wednesday, July 1, 2020.
 - If you do not receive confirmation of your submission by the Wednesday after the deadline, please email the point-of-contact identified in Section 2.07 of this RFP. Please do not ask for confirmation prior to the Wednesday after the deadline.
 - If you have submitted your proposal prior to the deadline and are unsure that your submission has gone through, please feel free to submit a second time. If you are resubmitting, please indicate in your email that this is a resubmission.
 - i. Again, those who submit proposals the day before the deadline will receive confirmation prior to the actual deadline.
