Hawai'i Visitor Statistics Released for October 2020

HONOLULU – Hawai'i's visitor industry continues to be severely impacted by the COVID-19 pandemic. In October 2020, visitor arrivals decreased 90.4 percent compared to a year ago, according to preliminary statistics released by the Hawai'i Tourism Authority's (HTA) Tourism Research Division.

On October 15, the state launched a pre-travel testing program, allowing passengers arriving from out-of-state and traveling inter-county to bypass the 14-day quarantine with a valid negative COVID-19 test result from a Trusted Testing and Travel Partner. As a result, slightly more travelers arrived in Hawai'i than in previous months, when testing was not an option to bypass the trans-Pacific quarantine requirement that began on March 26. Also in October, the County of Maui issued a stay-at-home order for all individuals on Lāna'i that began on October 27. In addition, the U.S. Centers for Disease Control and Prevention (CDC) continued to enforce the "No Sail Order" on all cruise ships.

During October 2020, a total of 76,613 visitors traveled to Hawai'i by air service, compared to 796,191 visitors who came by air service and cruise ships in October 2019. Most of the visitors were from U.S. West (53,396, -84.9%) and U.S. East (19,582, -86.8%). Only 183 visitors came from Japan (-99.9%) and 389 came from Canada (-98.8%). There were 3,064 visitors from All Other International Markets (-97.1%). Many of these visitors were from Guam, and a small number of visitors were from the Philippines, Other Asia, Europe, Latin America, Oceania and the Pacific Islands. Total visitor days¹ declined 81.7 percent compared to October of last year.

A total of 223,353 trans-Pacific air seats serviced the Hawaiian Islands in October, down 79.0 percent from a year ago. There were no direct flights or scheduled seats from Canada, Oceania, and Other Asia, and fewer scheduled seats from Japan (-98.6%), U.S. East (-74.3%), U.S. West (-72.5%), and Other countries (-54.6%) compared to a year ago.

Year-to-Date 2020

In the first 10 months of 2020, total visitor arrivals dropped 73.4 percent to 2,296,622 visitors, with significantly fewer arrivals by air service (-73.4% to 2,266,831) and by cruise ships (-74.2% to 29,792) compared to the same period a year ago. Total visitor days fell 68.6 percent.

Year-to-date, visitor arrivals by air service decreased from U.S. West (-73.2% to 1,016,948), U.S. East (-70.5% to 564,318), Japan (-77.5% to 294,830), Canada (-63.2% to 156,565) and All Other International Markets (-78.0% to 234,168).

Other Highlights:

• **U.S. West:** In October, 41,897 visitors arrived from the Pacific region compared to 271,184 visitors a year ago, and 11,496 visitors came from the Mountain region compared to 78,412 a year ago. Through the first 10 months of 2020, visitor arrivals decreased significantly from both the Pacific (-74.4% to 769,801) and Mountain (-69.1% to 226,657) regions year-over-year.

Alaska residents returning home were required to submit a travel declaration and self-isolation plan online, and arrive with proof of a negative COVID-19 test.

• **U.S. East**: Of the 19,582 U.S. East visitors in October, the majority were from the South Atlantic (-84.9% to 5,162), West South Central (-83.9% to 4,282) and East North Central (-87.8% to 3,594) regions. Through the first 10 months of 2020, visitor arrivals declined sharply from all regions. The three largest regions, East North Central (-67.2% to 117,060), South Atlantic (-74.3% to 107,721) and West North Central (-56.5% to 97,569) saw sharp decreases compared to the first 10 months of 2019.

In New York, a 14-day quarantine was required if a returning resident came from states with a significant degree of COVID-19 spread, defined as daily case rate of more than 10 in every 100,000 resident or a positive testing rate of higher than 10 percent.

- Japan: In October, 183 visitors arrived from Japan compared to 134,557 visitors a year ago. Of the 183 visitors, 128 arrived on international flights from Japan and 55 came on domestic flights. Year-to-date through October, arrivals declined 77.5 percent to 294,830 visitors. Japanese nationals returning from abroad were requested to refrain from using public transportation and to stay at home for 14 days.
- **Canada:** In October, 389 visitors arrived from Canada compared to 32,250 visitors a year ago. All 389 visitors came to Hawai'i on domestic flights. Year-to-date through October, arrivals dropped 63.2 percent to 156,565 visitors. U.S. borders with Canada were restricted since March 2020. Travelers returning to Canada must self-isolate for 14 days.

Highlights from All Other International Markets:

- Australia: There were 30 visitors who traveled to Hawai'i in October compared to 26,858 visitors a year ago. All 30 visitors came on domestic flights. Through the first 10 months of 2020, arrivals decreased 79.6 percent to 50,163 visitors. The Australian Government continued to impose a ban on all overseas travel for Australians, unless an exemption was granted. Residents returning to Australia were required to undergo a mandatory 14-day quarantine.
- New Zealand: There were 25 visitors in October versus 6,316 visitors a year ago. These 25 visitors arrived on domestic flights. Through the first 10 months of 2020, arrivals declined 83.5 percent to 10,826 visitors. The New Zealand Government advised New Zealanders to refrain from travel overseas due to COVID-19 health risks and travel restrictions. Residents returning to New Zealand were required to complete at least 14 days of quarantine and test negative for COVID-19 before entering the community.
- **China:** There were 72 visitors in October compared to 5,039 visitors a year ago. These 72 visitors arrived on domestic flights. Year-to-date through October, arrivals decreased 87.4 percent to 10,160 visitors. Since February 2020, a proclamation prohibited Chinese citizens from entering the U.S. due to COVID-19. Returning Chinese nationals were required to demonstrate

proof of a negative COVID-19 result issued no more than 72 hours before departure, performed by an approved provider, and were mandated to undergo a 14-day mandatory quarantine.

- Korea: There were 45 visitors in October versus 20,261 visitors a year ago. Of the 45 visitors, 43 arrived on domestic flights and two came on international flights from Japan. Through the first 10 months of 2020, arrivals fell 77.5 percent to 41,863 visitors. Korean citizens were allowed to visit the U.S. but were required to comply with state quarantine requirements. Residents returning to Korea were tested on arrival for COVID-19, required to install a Self-Quarantine Safety Protection App on their phone to monitor their health, and subject to a mandatory 14-day quarantine.
- **Taiwan:** Two visitors traveled to Hawai'i in October compared to 1,776 visitors a year ago. These two visitors came on domestic flights. Year-to-date through October, arrivals dropped 84.0 percent to 3,481 visitors. Taiwanese citizens were allowed to visit the U.S., but were required to quarantine for 14 days upon their return home.
- **Europe:** There were 152 visitors from Europe (United Kingdom, France, Germany, Italy and Switzerland) in October versus 14,892 visitors a year ago. These 152 visitors arrived on domestic flights. Through the first 10 months of 2020, arrivals decreased 82.4 percent to 20,869 visitors. EU Countries had varying levels of travel restrictions. In Germany, returning German nationals were required to present a certificate showing a negative result for COVID-19 issued no more than 48 hours prior to departure from a government-approved provider. Individuals who were unable to produce such a certificate were mandated to undergo testing upon arrival and were also required to self-isolate while awaiting their test results. In the United Kingdom, returning residents were required to self-quarantine for 14 days.
- Latin America: There were 117 visitors from Latin America (Mexico, Brazil and Argentina) in October compared to 2,062 visitors a year ago. These 117 visitors came on domestic flights. Year-to-date through October, arrivals dropped 74.5 percent to 5,471 visitors. Many of the Latin America nations were still in some form of lockdown or quarantine. Entry into the U.S. by Brazilian citizens remained suspended, per the U.S. Presidential Proclamation.

Island Highlights:

- **O**'ahu: In October, total visitor days decreased 82.8 percent compared to a year ago. There were 36,007 visitors on O'ahu in October compared to 469,339 visitors year-over-year. Through the first 10 months of 2020, visitor arrivals dropped 74.1 percent to 1,325,501 visitors.
- **Maui:** In October, total visitor days declined 83.1 percent from a year ago. There were 23,103 visitors on Maui in October versus 238,043 visitors a year ago. Year-to-date through October, arrivals decreased 75.0 percent to 637,315 visitors.
- **Kaua'i:** In October, total visitor days were down 77.9 percent compared to a year ago. There were 11,246 visitors on Kaua'i in October compared to 102,662 visitors a year ago. Through the first 10 months of 2020, visitor arrivals dropped 73.8 percent to 298,708 visitors.
- **Hawai'i Island:** In October, visitor days decreased 77.0 percent from a year ago. There were 10,640 visitors on Hawai'i Island in October compared to 130,336 visitors a year ago. Through the first 10 months of 2020, arrivals fell 71.4 percent to 416,122 visitors.

Air Seats to Hawai'i:

In October, total trans-Pacific air capacity dropped 79.0 percent to 223,353 seats, with 221,716 scheduled air seats (-79.0%) and 1,637 charter seats (-74.0%). Service to Hilo was suspended at the end of March 2020, and there were considerably fewer air seats serving Honolulu (-77.2% to 155,412), Kahului (-85.8% to 31,552), Kona (-72.3% to 23,045) and Līhu'e (-81.7% to 13,344) compared to a year ago.

- Scheduled air capacity from U.S. West decreased 72.5 percent in October to 188,037 seats. Service to Hawai'i from Anchorage, Long Beach, Salt Lake City and San Jose was suspended. Service from Denver (-62.6% to 12,366 seats), Las Vegas (-85.6% to 3,402 seats), Los Angeles (-73.3% to 53,482 seats), Oakland (-78.5% to 11,025 seats), Phoenix (-69.0% to 11,760 seats), Portland (-87.4% to 3,402 seats), Sacramento (-86.1% to 2,835 seats), San Diego (-83.8% to 4,725 seats), San Francisco (-65.7% to 42,774 seats) and Seattle (-50.6% to 42,266 seats) was significantly reduced compared to a year ago.
- Scheduled air capacity from U.S. East declined 74.3 percent in October to 19,523 seats. Most flights were suspended except for reduced service from Chicago (-60.5% to 5,037 seats), Dallas (-44.5% to 12,774 seats) and Houston (-84.8% to 1,712 seats).
- Scheduled air capacity from Japan dropped 98.6 percent in October to 2,254 seats. Nearly all flights were postponed except for limited service from Haneda (-98.5% to 372 seats) and Narita (-97.9% to 1,882 seats).
- There were no scheduled seats from Canada in October, compared to 21,383 seats a year ago.
- There were no scheduled air seats from Oceania in October, compared to 44,105 seats a year ago.
- There were no scheduled air seats from Other Asia in October, compared to 38,071 seats a year ago.
- Scheduled seats from Other markets (Apia, Christmas Island, Guam, Majuro, Manila, Pago Pago and Papeete) decreased 54.6 percent to 11,902 seats. Direct flights to Hawai'i from most routes were canceled except for Guam-Honolulu with 11,284 seats, which was unchanged from October 2019. Service from Manila-Honolulu was limited compared to a year ago (-88.9% to 618 seats).
- Year-to-date, total air capacity statewide decreased 62.1 percent to 4,278,381 seats, as a result of cutback in air service to Honolulu (-59.9% to 2,803,908 seats), Kahului (-65.8% to 816,083 seats), Kona (-62.9% to 390,573 seats), Līhu'e (-68.6% to 258,853 seats) and Hilo (-77.4% to 8,964 seats).

Cruise Ship Visitors:

• In October 2020, sails on the Hawai'i home-ported cruise ship were cancelled and out-of-state cruise ships were not permitted into the islands due to the CDC's "No Sail Order." During October 2019, 11,787 visitors came by air to board the Hawai'i home-ported cruise ship and 20,516 visitors came to the islands on 10 out-of-state cruise ships.
