Safe Travels Hawaii Program

Aloha! The State of Hawaii Safe Travels Hawaii program is designed to prevent the spread of COVID-19 in our community from trans-Pacific passengers arriving at airports/ports across the Islands.

The program includes the required online State of Hawaii Travel and Health Form, temperature screening at all Hawaii airports upon arrival, and the mandatory 10-day quarantine with the possibility of a vaccination exception, or a negative pre-travel test to bypass quarantine.

Travelers not participating in Safe Travels MUST quarantine for 10 days or the length of their stay, whichever is shorter.

<u>August 5, 2021 – Emergency Proclamation related to the</u> COVID-19 response

The August 5, 2021 proclamation states that effective September 13, 2021, the City and County of Honolulu will require all employees and customers of our restaurants (Sprigs Grille and Takumi) to have proof of COVID-19 vaccination or proof of negative FDA EUA approved COVID-19 test within 48 hours.
