QUESTIONS AND ANSWERS

- **1.** Regarding the MFF for 2022. Is it fully allocated, or is there a portion for any short term opportunities for 2022 business?
 - **a.** To date, a large portion of the MFF has been committed. There may be some funds available for short term opportunities for calendar year 2022 business.
- **2.** Based on potential Covid-19 related restrictions, is it assumed that the Oral Presentations will be in person and if so, is there a limit to the number of participants?
 - **a.** Yes, if oral presentations conducted, they will be in person. The evaluation committee will determine the number of presentation participants.
- **3.** Are the NI Chapter MCI staff to be covered in this RFP award?

- **a.** Island Chapter staffing for leisure is covered by a separate contract. All global MCI staffing will need to be covered by this RFP award.
- **4.** A simple question of why, in the deck presented during the Pre-Proposal Conference, there was not a DMAP Anchor Action slide for this island, but one for all others?
 - **a.** O'ahu was the last of the four counties to complete its DMAP, therefore, the progress of the Anchor Actions is still being assessed.
- **5.** Can two agencies partner on this submission?
 - **a.** Yes. You are welcome to enter together as a joint venture, a legal partnership with a unique company name, or as a contractor/subcontractor team.
- **6.** Does the contact person listed on cover page of proposal need to match the contact person listed on our Intent to Apply form? (Page 5/Section 1/Paragraph 1.07 and Page 18-19/Section 3/Paragraph 3.10)
 - **a.** No. The company should match, but the contact person can be different. An exception regarding company name would be made for those who are entering as a new partnership, so long as at least one of the entities had registered an intent to apply.
- **7.** May offerors submit additional attachments or only those listed in the RFP? (Page 18/Section 3/Paragraph 3.09)
 - **a.** No, please only submit what is required according to the RFP. Additional information or collateral may be requested of those who advance to the oral presentation round.
